**POLLUTION FREE ENVIRONMENT**

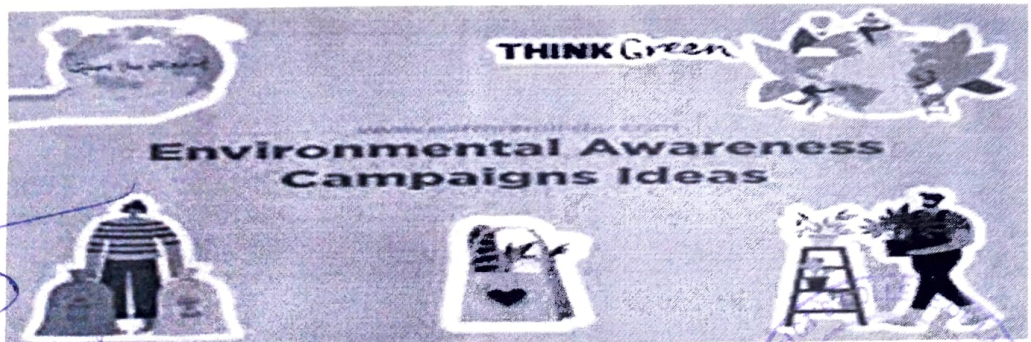




The research conducted by MCT College of Law involved a combination of data collection, surveys, field observations, and interviews with experts in various environmental fields. We examined the levels of pollution in the college's vicinity, as well as the larger community it serves. The study spanned several months, allowing for a thorough and accurate analysis of the pollution sources and their consequences.

Our study found that air pollution was a significant concern in the region. Emissions from transportation, industrial facilities, and energy production were identified as primary contributors. Measures such as stricter emissions standards, encouraging the use of public transportation, and promoting clean energy sources were recommended to address this issue.

Water pollution emerged as a concern, primarily due to agricultural runoff and inadequate wastewater treatment. The college's research suggested enforcing regulations for industrial and agricultural waste disposal and implementing sustainable farming practices to mitigate water pollution.
